Split Rock Resort is proud to invite you to participate in our 33<sup>rd</sup> Annual Great Tastes of Pennsylvania Wine & Food Festival, on Saturday and Sunday, June 22, and 23, 2024. Once again, we look forward to the opportunity to work with our wineries for a most successful event! The festival will feature tastings from Pennsylvania's finest wineries, musical entertainment, crafts and food during this two-day event.

Winery space size is 20x20, under a shared tent, with locations and placement at the discretion of the Festival Committee. Suggestions and requests for specific locations are accepted, but not guaranteed. The application fee includes (2) festival wristbands, (4) vendor wristbands, and (2) souvenir wine glasses. Tables and chairs are not included in your application fee, but can be rented for an additional fee of \$18.00 per table and \$8.00 per chair.

Please complete the application form and email or mail it per instructions on the actual application. Once your application has been accepted, you will receive general confirmation of your participation. There are no refunds after your application has been accepted, and we do require that you agree and sign the additional Terms of Participation form on this link.

Rooms will be released to the general public for sale on March 15<sup>th</sup>, 2024, so please ensure your reservations are confirmed prior to this date to ensure you receive your discount. Vendor rooms will have a two night minimum required to be able to book this discounted rate.

**Winery - Terms of Participation:**

- **This event is rain or shine. There is no rain date.** The festival will operate from 12:00pm to 5:00pm each day unless there are catastrophic conditions causing a change or cancellation.
- **A current copy of your Winery's Certificate of Insurance is required at time of application submission.** Please ensure that SCH USA, LLC, Split Rock Hotel by Bel Air and Split Rock Investments and SRWP, is included in the additional insured area. **Physical address: 428 Moseywood Road, Lake Harmony, PA 18624.** Without this being executed properly, the COI will be returned to the vendor for proper correction.
- **Wineries are responsible for applying to the PLCB for the Exposition Permit.** A copy of this permit is required to be submitted no later than June 1, 2024.
- Electricity is available in specific areas. Please contact us should you have any questions regarding electric. **Generators are NOT permitted in this festival.**
- Security will be provided from 6:00pm, Friday to 8:00am, Saturday, and 6:00pm Saturday to 8:00am, Sunday; however, Split Rock Resort and the festival staff is not responsible for any losses or damages before, during or after the event.
- Selling and taste testing spirits/beer to attendees is prohibited by all wineries and vendors. Any winery or vendor that violates this rule will be asked to leave and will not be permitted back to future events/festivals at Split Rock Resort.
- **Selling of wine and/or wine slushy by the approved festival wine glass is prohibited.** Permission is granted for sales of sealed bottles of mead by the 375ml bottle and/or the pre-packaged/sealed slushy (with the TTB approved labels in place).
- Once your application and payment has been accepted, there are no refunds given for any cancellation on the part of the vendor. Should a cancellation occur, there is no guarantee the vendor will be permitted back to future events/festivals at Split Rock Resort.
- Festival committee members will be present to direct wineries to their locations between 12:00pm and 6:00pm on Friday, June 21, 2024, and again on Saturday, June 22, 2024, from 8:00am to 11:00am. All vehicles must be off of festival grounds by 11:00am each day. Parking for trailers, large trucks and/or individual vendor vehicles will be available on our first ski hill.
- While location suggestions and requests are accepted, all winery locations will be at the discretion of the festival committee.
- Pets are **NOT** permitted on festival grounds.

### **Wine Check Information:**

The wine check tickets that you will be provided have three parts:

1. Give one copy to the customer.
2. Stick one copy to the top of the wine filled box – **ensuring that this copy is fully filled out with customer's last name for all to read.**
3. Keep one copy for your winery.

### **Wine Check Tips:**

- Winery name needs to appear on all three wine check stickers.
- Stickers MUST be on the top of the box.
- Boxes with less than (3) bottles of wine/mead/slushy bags, will not be accepted.
- Secure box with packing tape – pay special attention to the bottom of the box.
- Bags and gift items will not be accepted for wine check.
- Please communicate with the festival staff to ensure proper location set up of the wine check pick up at your tent, and place the pallet in this area so the bottom of the boxes do not get wet or break apart. This helps us with ensuring the efficiency of our wine check procedures

### **Departure/Load Out:**

- Please do not fully depart before Security permits on Sunday, June 23, 2024, as this is important for the safety of all our guests. Security will be present to ensure guests are removed from the grounds before vehicles are permitted to enter for load out.
- Please clean your area before departing. There will be a \$500.00 fee for sites left in an unacceptable condition.
